No person, firm, corporation, joint-stock company, syndicate, or association having at least a five percent (5%) ownership interest in the applicant or any person to be employed or designated in the distribution or sale of beer has been convicted of, or released from incarceration for any violation of the laws against possession, sale, manufacture, or transportation of beer or other alcoholic beverages or any crime involving moral turpitude within the past ten (10) years.
- 6. Multiple events for a period not to exceed six (6) months may be submitted on one application. All dates and times must be firm. Alternate rain dates and locations may be submitted. NO CHANGE CAN BE MADE AFTER APPROVAL BY THE BEER BOARD WITHOUT FILING A NEW APPLICATION.
- 7. A non-refundable \$250 application fee must accompany all applications.
